CRP - June 15

Hand Control Subcommittee:

- Update from Hand Control subcommittee, had three manufacturers join the committee and everything was positive concerning the spec.
- General consensus was that there was nothing in the draft spec that was going to be a concern, everyone was on-board

CRP Website:

- CRP is not only easy to understand from a consumer standpoint, but the CRP postings are hard to navigate to, it take a minimum of 3 clicks to get to the page
- Need to make the CRP easier to get to, also consider changing the name to something easier to understand like "Consumer Safety" or "Vehicle Safety"
- Team also needs to work on new 'tag' line, current line is "Always working for your safety" but the teams consensus is that does not 'grab' the audience, nor does it convey what CRP is about
- Team to submit ideas for new tag line (Action item)
- Also next meeting team will discuss Objectives and Strategies for the CRP portion of the website and formulate a Marketing plan to provide to the marketing committee and web designers (Action item)

Window Cling:

- Agreed on window cling being about 12" x 12" and used in showroom or on the dealer lot
- Samples of material being sent into NMEDA office
- Would like to change wording on the cling to align with strategic objective of rebranding as
 "QAP", so would like to say "NMEDA-QAP" and instead of saying CRP or Compliance Review
 Program, say something like "Product Safety Group"
- Initial order will be small and sampled by 2-4 dealers

CRP Components:

- Need to compile a listing of proposed mobility equipment to be posted on CRP
- Team to submit ideas on what equipment will go on the list, send to Chuck and he will collect and summarize for the next meeting (Action item)
- Team will prioritize list at next meeting

WC-20 and WTORS:

- WC-20 is for seat cushion and seat backs and is a companion for the WC-19 wheelchair frame
- WC-20 will have no impact on WTORS

Conference - July 9

- Keynote Speakers: A motion was made to select Gary Schwartz as the keynote speaker. The
 motion was seconded and passed. Tammy Duckworth is an option for the Friday morning
 keynote. Dave will line up a few backup speakers for Friday morning that would have more
 education content.
- Conference Schedule Content & Friday discussion: The schedule was approved as presented after changing Sales Value Speaker on Friday was changed to Speaker and eliminating the 4:15 5 pm slot on Thursday.
- Conference Theme: "The Great NMEDA Roundup Think Big" was selected as the theme.
- Exhibitor Pricing Structure: Pricing structure for non-member exhibitors was discussed. A motion was made to approve \$1950 as the non-member pricing with a \$500 increase in 2017. The motion was seconded and approved.
- Discount for first year exhibitor: A discount will not be offered to new exhibitors.
- **Guidance for exhibit hall**: MQAP designation will be identified in the exhibit hall.
- **New member rebate**: The committee agreed to offer a rebate to a non-member that applies and successfully becomes a member. This will be included in the brochure and exhibitor information.

Education & Training – June 25

- PBT: Pete called members close to UTI facilities to determine the outcomes for posting vs.
 placements. Received feedback that the automotive tech category was very competitive.
 Suggested a possibility of posting salary/wage ranges. No placements have been recorded yet, but reports are that the experience has been positive.
- **CAMS-HP**: The CAMS-HP DC training was completed and very well received. NMEDA has produced three CAMS-HP courses so far this calendar year with two to five planned for the remainder for the year. Working to finalize a 3 hour course for CWTA to complement existing Lunch & Learn version. Anticipate finished courses by the end of summer.
- **NCT**: Discussed adding a course to the program regarding the determination of weight ratings. This subject can be confusing to many dealers. Could be a supplement attachment to the existing make inoperative module hosted on Brainshark.
- **DM**: Announced that Ford will be delivering a product webinar for the NMEDA membership in the coming year's OEM Series. OEMs currently scheduled to present are Ford (Sept.24), Honda (Oct.) Chrysler (Nov.), and Mobility Ventures (Dec). Unclear on the status of Toyota.
- Influencer Referrals: Pete and Bruno are working on prioritizing potential partner associations (Veterans-Professional-Consumer) to explore mutually beneficial relationships and are in the process of determining which are key to reach out to in an effort to brand QAP. So far, 26 of 86 associations in the matrix have been qualified with 12 ranked as "high priority." Partnership proposals have been accepted by ADED (QAP logo displayed in locator) and ASA (exchange social media schedule and "Driving after Stroke" landing page re-write. National MS Society and Reeve Foundation partnerships are in process.
- Paul Webb Training Course: Discussed the idea of developing a complete 15 hour online sales training course with Paul Webb TV for the exclusive use of the NMEDA membership. Discussed potential cost and the possibility of charging membership a nominal fee for training access to

help offset costs. The committee voted to proceed with developing a sales training program for presentation to the Board.
